Beneficiary Pension Application - Determination of Dependent

**Child Status:** 

The Committee reviewed a Beneficiary Pension Application to determine whether Mr. Francisco J. Villela, Jr. met the criteria for a beneficiary pension under the Pension Law. Updated medical documentation had been submitted and the applicant and his caregiver were in attendance and provided the Committee additional information. After considering all the information, Mr. Reed moved to recommend to the Board approval of the beneficiary pension application. The motion carried unanimously. Mr. Reed also moved to recommend to the Board that the annuity for Mr. Villela be adjusted as allowed by Section 6.02(j) of the Pension Law to accommodate the state and federal assistance he is receiving, and to reallocate the annuity in accordance with the Pension Law. The motion carried unanimously.

# Reduction(s) of Disability Retirement Benefits Due to Outside Income or Medical – Individual Pensioner Cases

The Committee next reviewed information regarding Police Officer Robert Milks who had previously been identified by the Committee as earning income in excess of the threshold established by the Board's policy on Excessive Outside Income. Mr. Milks was in attendance at the Meeting and provided the Committee additional information regarding his job duties and salary. After a lengthy discussion, the Committee decided to take no action at this time.
