# ADMINISTRATIVE SERVICES CONTRACT RENEWAL WITH THE CITY OF SAN ANTONIO

Mr. Schott reminded the Committee that the Pension Fund's Administrative Services Contract with the City of San Antonio expires in September. He reported that negotiations have begun but that certain items may require more direct conversations with City leadership. The Committee directed Mr. Schott to coordinate a meeting with City leadership, as appropriate.

### POLICY REVIEW AND RECOMMENDATIONS

<u>Membership Disclosure Policy.</u> General Counsel Gail Jensen reminded the Committee of the need to rescind and/or update the current Membership Disclosure Policy. She presented the Committee with two possible drafts of the updated "Member Communication Policy". After discussion, Mr. Reed moved to

recommend to the Board to rescind the current Membership Disclosure Policy and approve the Member Communication Policy, Option 2. The motion carried by a vote of 2:1, with Mr. S. Griffin opposing.

<u>Public Information Policy</u>. Ms. Jensen informed the Committee that the Board's Public Information Policy, adopted in 2008, was outdated and should either be updated or rescinded. She noted that the provisions of the Policy are governed by state law and so the policy is largely unnecessary. After discussion, Mr. S. Griffin moved to recommend to the Board to rescind the Board's Public Information Policy. The motion carried unanimously.
